

32 This non function has been brought about by the fact that none of the members call the
33 Sunshine Board to let them know that a member is in need of aid and/or cheer. There has
34 been a drastic increase in the advent of Day Surgery and being treated at a hospital or
35 clinic and sent home on the same day. Most surgeries are now done and the person is sent
36 home either the same day or the next morning thereby making it such that the member is
37 home prior to the call to the Sunshine Board. The Treasury of the sunshine board is
38 currently disbursed by and through the Grand Secretary and Grand Treasurer.
